F. Reports from DEAP Management

- Head Administrator's Report
 Dr. Jimenez provided data sheets on absences, enrollment history, and tardies/check-outs. She
 will be making home visits to four families based on students' high absences.
- Finance Manager's Report
 Kay Girdner, our temporary finance manager, announced Donna Overson as our new finance
 manager. An Encumbrance Report for July 1, 2016 to January 31, 2017 was demonstrated to
 the board.
- 3. Director of Curriculum's Report Kayla Begay provide insight into community services performed by DEAP students. Ms. Begay also reflected on the Santa Fe fieldtrip where students visited our sister school, NACA, the Institute of American Indian Art, Meow Wolf, the Roundhouse, and the Santa Fe Plaza. PAC is working on fundraisers to assist in an upcoming fieldtrip in May 2017. February 20, 2017 is Leadership Day and the students are going to be making moccasins for Navajo and Crystal Headstart Programs.
- 4. Director of Operations' Report Prestene Garnenez reported the students have had 4 snow days to date, an emergency evacuation for an accidental gas line break during demolition of the old recreation center, and a school cancellation due to the risk of smoke inhalation from the burning recreation center last Fall. The Santa Fe fieldtrip was successful and another trip is in the process. Ms. Garnenez is working to ensure that Dr. Jimenez is becoming more acquainted with DEAP. PED has scheduled a site visit for February 14, 2017. The PAC has elected a new chair, Margie Apache.
