1. Head Administrator's Report

Louella Poblano e-mailed her report prior to the meeting. She announced updates for NMPED & PEC, DEAP student enrollment and staff, and Governing Council. Mrs. Poblano declares a scheduled meeting with Commissioner Chair Patricia Gipson regarding DEAP's Corrective Action Plan on January 17, 2018 at 10:00 am in Santa Fe, NM. The following people are the Action Team: Benita Litson, Gavin Sosa, Sean Fry, Louella Poblano and Prestene Garnenez. She states the Annual Charter School Site visit is scheduled for Thursday, March 8, 2018. Two students have withdrawn from DEAP leaving student enrollment at 26. Staff has grown from 7 to 10 with the possibility of one more addition. Mrs. Poblano follows up on the Governing Council survey and self-evaluation and Head Administration evaluation. Rubrics were shared via e-mail.

Prestene Garnenez announces grants from NISN: Native American Youth Program and High-Quality Charter. Ms. Garnenez implies more clarity is needed on the NISN General grant. The E-Rate grant will be used for DEAP's internet broadband services which has been increased from 15 GB to 20 GB within the SY 2017-2018. The Indian Education Grant is solely for the use of College/University Field Trips, Cultural Experts for student teaching, supplies and student support. Ms. Garnenez proclaims the 50k from SY2015/2016 has been reauthorized with GMCS. There are three options for use of the fund focused on expanding the facility: purchase new/used modular, rehab the old fire station and sub-station, or buy GMCS portables and renovate to meet safety requirements.
