5. Hiring Process of the Head Administrator

- 2. Finance Manager's Report: Carmen read her report and projects the year will end on a positive note. Prestene and Daniel are working on the next phase of funding.
- 3. Director of Curriculum's Report: Ms. Kayla Begay presented changes in the Personal Wellness schedule, assistance in the community gardening project and working with Dine College and New Mexico State University, and looking to improve DEAP, community and family relations/involvement with two students' grandparents coming into classes.
- 4. Director of Operation's Report: Ms. Prestene Garnenez reported support with the community garden project with help from Tsehootsooi Medical Center and Whole Kids grant to purchase supplies, tools and materials. Upcoming fields trips utilizing the Wells Fargo Golden Apple grant. DEAP is a AmeriCorp VISTA volunteer worksite and will be bringing on new help. Ms. Karen Mailman is also rejoining DEAP staff as of March 1. She noted that the Governing Council must complete 5 hours of training each year and offered some dates for upcoming opportunities.
- 5. Governing Council's Fundraising Report: Ms. Shayla Yellowhair reported on strategies to help fundraise for DEAP; the GC is asked to help with fundraising via the website. Other fundraising include Boxtops with students and their families.
