C. Review and Approval of Agenda

D. Review and Approval of August 09, 2017 Meeting Minutes and June 2, 2017 Special Meeting Minutes

A motion to approve August 09, 2017 Meeting Minutes and table June 2, 2017 Special Meeting Minutes made by Gavin Sosa and second by Benita Litson. The vote was 3-0-0.

- E. Discussion and possible Action Items:
 - 1. Approval of Budget Adjustment Requests (BAR)

Sean Fry presented BARs in the amounts of:

\$1,000.00 for Running Strong

\$35,000.00 for Futures for Children

\$12,437.00 for NISN Native American Grant

Ms. Benita Litson made a motion to approve BARs and second motion was made by Gavin Sosa. The vote was 3-0-0.

2. Approval of Facilities Usage Form

The Governing Council discussed the form; however, because the form was submitted to the GC without appropriate information a motion to table the approval of the Facilities Usage Form was made by Benita Litson with a second motion made by Gavin Sosa. The vote was 3-0-0.

- 3. Amendment to Charter Contract for mixed grades Ms, Kayla Begay, Director of Curriculum, reiterated the amendment had been presented prior however, to amendment was not submitted to the PEC due to other ongoing issues with the revocation hearing and audit. However, with school in session and more accurate information as to student enrollment per grade the support for mixed grades appears stronger. The Governing Council discussed it at length and a motion to approve the Amendment to Charter Contract for mixed grades in Native Literature and Indigenous Science was made by Benita Litson and second motion by Gavin Sosa. The vote was 3-0-
- 4. Approval of NISN AmeriCorps Program MOU
 The Governing Council reviewed and discussed at length the Memorandum of
 Understanding between DEAP and NISN. The Governing Council recommended to
 request separate MOU's for the AmeriCorps program and the MOU defining the
 relationship between DEAP and NISN. They also recommended Head Administrator,
 Louella Poblano, and Governing Council Member, Gavin Sosa, prepare letters stating as
 such to NISN. A motion to table the approval of NISN AmeriCorps Program MOU was
 made by Benita Litson and Gavin Sosa. The vote was 3-0-0.
- Acceptance of Audit Committee members
 New DEAP parent, Regina Bitloy requested to be part of the DEAP Audit Committee. A
 motion to accept Ms. Bitloy as a new Audit Committee member was made by Benita
 Litson with a second motion by Gavin Sosa. The vote was 3-0-0.
- Governing Council Membership
 Quorum was lost before the motion and vote of the removal of Regina Manygoats as Vice-President; thus, she remains as the Governing Council as Vice-President.

Quorum was lost due to a call disconnection with Gavin Sosa at 7:22 PM. Meeting ended at 7:22 PM
